OPTIONAL PRE TOUR

Day 1: August 4, 2025 • Depart USA

Our journey begins as we board our flights for Hiroshima Japan. We cross the international date line in the middle of the Pacific, so our arrival is two days later (local time). Plenty of time for a few movies, a couple of meals and a nice nap.

Days 2: Tuesday August 5, 2025 • Hiroshima

Upon arrival, we meet our local guide and transfer to our hotel with time to relax from our flight and freshen up before dinner at a local restaurant. **D**

Day 3: Wednesday, August 6, 2025 • Hiroshima

We visit Hiroshima Peace Memorial Park, which was the epicenter of the first atomic bomb attack during WWII. We tour the museum and the many monuments in the park. This afternoon we visit Hiroshima Castle and Museum of Art. We have time to enjoy the Hondori Shopping Street. (Note: There is a ceremony on August 6 to mark the detonation of the bomb.) **B**, **D**

Day 4: Thursday, August 7, 2025 • Hiroshima

Mijajima Island is a small island a short distance outside of Hiroshima. We take a short ferry to the island where feral deer greet us. We tour the shrine at the entrance to the island and take the ropeway up to the top of Mount Misen. There is time on our own to visit the aquarium, the temple site on the side of the mountain, or enjoy a leisurely lunch of grilled oysters (a local delicacy). This evening, we return to the city





for a group dinner, and possibly a baseball game if the team is in town. ${\bf B}, {\bf D}$

Day 5: Friday, August 8, 2025 • Tokyo

We check out of our hotel and take the bullet train to Tokyo where we meet up with the rest of our group. **B**

MAIN TOUR

Day 1: August 7, 2025 • Depart USA

Our journey begins as we board our flights for Tokyo, Japan. We cross the international date line in the middle of the Pacific, so our arrival is two days later (local time). Plenty of time for a few movies, a couple of meals and a nice nap.

Day 2: Friday, August 8, 2025 • Tokyo

Upon arrival we meet our local guide and transfer to our hotel in Tokyo with time to relax from our flight and freshen up before dinner at a local restaurant. We meet up with the early arrivals on the pre tour. **B**, **D**

Day 3: Saturday, August 9, 2025 • Tokyo

Today, we explore the magnificent Imperial Palace East Gardens and soak in the serene beauty of the heart of Japan's imperial history. Then we venture to the lush and tranquil Meiji Shrine in Harajuku. We stroll through the forested paths and experience a moment of peace at this revered Shinto shrine. The Meiji Shrine, a perfect blend of historical charm and natural beauty. We continue to the bustling district of Ginza for a leisurely lunch on our own and some time to explore the shops. This afternoon we visit the Edo-Tokyo Museum in Ryogoku and learn about the rich history and vibrant culture of Tokyo from the Edo period to the present day. **B**, **D**

Day 4: Sunday, August 10, 2025 • Tokyo

Our day begins as we visit one of Tokyo's historic districts, starting with a visit to Asakusa. Starting at the iconic Kaminarimon (Thunder Gate), we stroll through Nakamise Shopping Street where we admire the towering two-storied Hozomon Gate and the striking five-storied pagoda before reaching the centerpiece of the complex, the Senso-ji Buddhist Temple, a revered site first built in 645 AD. We continue to the Asakusa Shinto Shrine, a beautifully preserved structure dating back to 1649. Afterward, we enjoy some free time to wander through the charming side streets, savor a leisurely lunch, and capture memorable photos. We



return to the hotel and later, we enjoy dinner in Shinjuku, where the dazzling neon lights provide a spectacular backdrop. **B**, **D**

Day 5: Monday, August 11, 2025 • Akita

This morning, we board the Shinkansen Bullet Train for Akita. The 370-mile ride takes approximately four hours, so settle in with a good book or movie. You may want to visit the dining car for a snack, or order from one of the vendors passing through the train. Upon arrival we renew friendships and form new friendships in our sister city. **B**, **D**

Day 6: Tuesday, August 12, 2025 • Akita

This morning, we tour the city's Senshu Park and Museum of Art. In the afternoon, we have some demonstrations of Akita's heritage - the soba noodle, kiritanpo rice skewers, lacquerware, and the Namahage Ogre. **B**, **D**

Day 7: Wednesday, August 13, 2025 • Akita

We spend one final day with our friends in Akita. Later, we have time to reflect on our journey over dinner. **B**, **D**

Days 8: Thursday, August 14, 2025 • Return

We say "Sayonara" to Japan, as we head to Akita Airport for our flights back to the USA. Our hearts are full of the memories we made and friendships formed in Japan.

Currency:

Currency exchange rates fluctuate constantly. In the event of a significant drop in the value of the dollar, we reserve the right to add a currency surcharge to the price of the tour.

Refund/Cancellation Policy:

All cancellations must be in writing. The date of postmark will determine the amount of refund due. Refunds are based on the number of days prior to departure date. From the time of deposit to 120 days before departure a \$100/person administrative fee plus any airfare & land penalties will be assessed. From 119-31 days, a \$300/person cancellation penalty plus lost airfare deposits and any unrecoverable deposits to ground suppliers will be assessed. Airline tickets once purchased are nonrefundable. Anyone canceling 30 days or less prior to departure will receive no refund.

Purchase of health, baggage, and trip cancellation/interruption insurance is strongly recommended.
