All cancellations must be in writing. The date of postmark will determine the amount of refund due. Refunds are based on the number of days prior to departure date. From the time of deposit to 99 days before departure a \$50 administrative fee plus any land penalties will be assessed. From 99-14 days, a \$250 cancellation penalty plus any unrecoverable deposits to ground suppliers will be assessed. Anyone canceling less than 14 days prior to departure will receive no refund.

Purchase of health, baggage, and trip cancellation/interruption insurance is strongly recommended.

Terms and Conditions:
