Day 1: Tues, October 10, 2023 • Departure Our tour begins today with our departure to Venice, Italy.

Day 2: Wed, October 11, 2023 • Venice

Upon our arrival in Venice, we take a boat taxi to our hotel on fabulous Venice–La Serenissima, the "Serene One." Built upon 117 islands, Venice is a mosaic of canals, plazas, fascinating markets, and chaos! This afternoon we head to Murano–a cluster of small islands connected by bridges and the center of the Italian glassmaking industry since 1291. **D**

Day 3: Thurs, October 12, 2023 • Venice

We begin our day in Venice with an excursion to St. Mark's Square, including a cruise along the serpentine Canale Grande. Here a local guide shows us the Bell Tower and the impressive St. Mark's Cathedral. We have the remainder of the day and evening on our own in Venice. **B**

Day 4: Fri, October 13, 2023 • Venice

We have an entire day free in Venice to explore other islands with our included vaporetto passes, visit museums or do a mask-making workshop, or perhaps shop along the Rialto Bridge. Later we rejoin the group to share stories of our day at dinner together. **B**, **D**

Day 5: Sat, October 14, 2023 • Lucca

Departing Venice, we now journey southward into the region of Tuscany, often described as the "heart of Italy." Our home



tonight is Lucca, a Roman-style city surrounded by massive red brick walls. Our sightseeing stops today include the famous Leaning Tower of Pisa. Upon our arrival in Lucca we tour this wonderful city. The rest of the day is free to relax and explore before dinner as a group at the hotel. **B**, **D**

Optional: Leaning Tower of Pisa Tour \$25 per person.

Note: Tickets need to be purchased in advance. The visit takes about 30 minutes. The climb is on foot with 251 steps. The visit is not recommended for people with cardiovascular and muscular disorders. The floor is uneven and slippery.

Day 6: Sun, October 15, 2023 • Lucca

Today we have an excursion to the Cinque Terre, a series of fishing villages. We begin with a boat ride along the sea and then return by train and on foot. These villages have a special character, as we observe the life of the fishermen and the abodes to which they return. **B**, **D**

Day 7: Mon, October 16, 2023 • Siena area

Our first stop today is Florence, the Cradle of the Renaissance. Florence is home to the Duomo with its famed Baptistry, Giotto's Tower, the Pitti Palace, the Accademia with Michelangelo's incomparable David, and the Uffizi Gallery with the finest collection of paintings in all of Italy. We take time for exploring the sprawling San Lorenzo Leather Market and the shops along the Ponte Vecchio. Time permitting, we stop at the American Cemetery of Florence.







Here we see the graves of thousands of GI's who fell while fighting their way "up the boot" of Italy. **B**

Day 8: Tues, October 17, 2023 • Siena area

On our agenda today is the lovely city of Siena. A locallyguided tour of this fabulous Gothic city acquaints us with its sunken Piazza del Campo and the Duomo-perhaps the finest Gothic cathedral in Italy! The rest of the day is free to explore Siena. Tonight, we have a wine-tasting and dinner. **B**, **D**

Day 9: Wed, October 18, 2023 • Rome

This morning we travel east and enter the region of Umbria, where we arrive at its most beautiful town, Assisi. A local guide acquaints us with the life of Saint Francis as we enter the magnificent Basilica di San Francesco. The upper level is filled with stunning frescoes that were restored following the 1997 earthquake, while the lower level is where St. Francis is buried. After lunch and plenty of free time to further explore this serene and picturesque town, we drive to our hotel in Rome. **B**, **D**

Day 10: Thurs, October 19, 2023 • Rome

Our day includes a visit to Vatican City and St. Peter's Cathedral, home of the Roman Catholic Church and the largest building in Christianity. Also included is a visit to the Vatican Museums and the Sistine Chapel. We have free time to visit the city center in the afternoon. **B**

Day 11: Fri, October 20, 2023 • Rome

After breakfast, we begin our sightseeing in the Eternal City of Rome and the glories of the Caesars. We become acquainted with the city that was the birthplace for much of our civilization as we visit the Capitoline Hill area, from which we view the Roman Forum. We also experience sights such as the Colosseum, Constantine's Arch, and more. Tonight, we have our farewell dinner. **B**, **D**

Day 12: Sat, October 21, 2023 • Return

This morning, our driver returns us to the Rome airport, where we say "Ciao," and board our flight for our return home. ${\bf B}$

Payment Schedule:

A deposit of \$500 per person is due with reservation. Final payment is due 100 days prior to departure date. Invoice will be sent out prior to final payment. Passengers may add after this date subject to air and land availability. Generally airlines do not increase the price of a ticket after it has been contracted. However, prior to the issuance of a ticket, airlines may (and regularly do) impose fuel, tax, or security surcharges. In the event a surcharge is imposed after Ed-Ventures has received a final payment, Ed-Ventures will send an additional invoice for the surcharge amount. Early registration is encouraged.

Currency:

Currency exchange rates fluctuate constantly. In the event of a significant drop in the value of the dollar, we reserve the right to add a currency surcharge to the price of the tour.

Refund/Cancellation Policy:

All cancellations must be in writing. The date of postmark will determine the amount of refund due. Refunds are based on the number of days prior to departure date. From the time of deposit to 100 days before departure a \$100 administrative fee plus any airfare penalties will be assessed. From 99-31 days, a \$300 cancellation penalty plus lost airfare deposits and any unrecoverable deposits to ground suppliers will be assessed. Airline tickets once purchased are nonrefundable. Anyone canceling less than 30 days prior to departure will receive **no refund**.

Purchase of health, baggage, and trip cancellation/interruption insurance is strongly recommended.

Terms and Conditions

We reserve the right to cancel this trip due to lack of subscription. In the event of cancellation of the trip in its entirety, a full refund of all deposits will be made to passengers enrolled at the time of cancellation. Any changes in airfare booking may result in a processing fee.
