Sunday, July 11, 2021 • Depart USA

We begin our exciting journey to the beautiful Alpine countries as we board our flight to Frankfurt. This tour presents the natural beauty, dynamic history, and special traditions found in Germany, Austria, and Switzerland. IF

Monday, July 12, 2021 • Rothenburg

Upon arrival in Frankfurt, we meet our driver and depart immediately for Wurzburg – a city along the river Main surrounded by huge parks and vineyards. We enjoy a short tour of the Residenz which was built from 1720 – 1744. The Residenz is the main work of south German Baroque and one of the most important castles in Europe. Since 1982, the Residenz has been included in the UNESCO World Heritage List. We then continue on to Rothenburg, one of Germany's greatest treasures – the city that time passed by. Preserved as a kind of national monument – no one is allowed to change anything within the city walls which date back hundreds of years. This evening we stay at the Schranne in Rothenburg. **IF/D**

Tuesday, July 13, 2021 • Rothenburg

This morning we have a tour of Rothenburg – the medieval walled city – which acquaints us with this truly charming gem. As we admire the handsome, half-timbered buildings and walk the narrow and winding cobblestone streets and ramparts, we realize that we are truly stepping back over 500 years in time. Afterwards you have some free time to relax if you wish or simply stroll through this enchanting village. Sit down at a sidewalk café, order a brat and a beer, and just enjoy the atmosphere of this old German city. You also find that this is one of the best places to shop while on tour. **B/D**

Wednesday, July 14, 2021 • Salzburg

We leave Rothenburg and drive to Salzburg today. Salzburg is one of the most beautiful cities in Europe. In Salzburg we take a walking tour of the "old city" and see some of the sights of the Sound of Music. The tour also includes the Mirabell Gardens, the Mammoth Cathedral, and the famous Getreidegasse, a pedestrian shopping area. In the evening we enjoy the very popular "Sound of Music" Dinner show located in the old city. **B/D**

Thursday, July 15, 2021 • Salzburg

This morning we take a very exciting bus ride to visit Hitler's Eagles Nest, perched high above the city of Berchtesgarden. From the Eagle's Nest you are treated to a spectacular view of



the countryside below including SALZBURG in the distance. The afternoon is free for you to explore Salzburg and spend some time shopping in the famous Getreidegasse in the old city. **B/D**

Friday, July 16, 2021 • Oberammergau

Today we leave Austria and travel back into Germany to the beautiful Bavarian village of Oberammergau, where the famous Passion Play is held every ten years. On the way, we stop in Munich and walk through the famous Marienplatz where we can see the Glockenspiel on the new city hall and stop in at the renowned Hofbrauhaus to listen to some music and have refreshments if you wish. We are staying at the Alte Post in Oberammergau. **B/D**

Saturday, July 17, 2021 • Oberammergau

Today we visit Linderhof, another one of the King Ludwig's Castles. It is smaller than Neuschwanstein but a much more ornate castle, trimmed with gold leaf. We return to Oberammergau where you have a chance to relax and enjoy the German village and even shop for wood carvings – something this region is quite famous for. **B/D**

Sunday, July 18, 2021 • Lucerne


We are leaving Germany once again and traveling into the majestic country of Switzerland. On the way, we stop at Vaduz, the capital of Liechtenstein for lunch and then continue on to Lucerne, Switzerland. Lucerne is the storybook image of a Swiss town, abounding in cobblestone streets, spires and turrets, covered bridges, frescoed houses and fountains. We also see the famous Lion Monument and the Chapel Bridge. **B/D**

Monday, July 19, 2021 • Lucerne

After breakfast, we begin a full day excursion into the Swiss Alps. We drive to Stechelburg, just outside of Interlaken, and take a cable car to the Piz Gloria, a 360-degree solar-powered revolving restaurant on the Schilthorn mountain peak where we have lunch. Excerpts from James Bond film, "On Her Majesty's Secret Service" were filmed on the Schilthorn. Tonight, we have dinner and a Swiss Folklore show. **B/L/D**

Tuesday, July 20, 2021 • Black Forest

We leave Switzerland and drive to Lake Konstanz on the border between Germany and Switzerland. Here we visit the famous tropical island of Mainau to see the very beautiful tropical gardens. From spring through autumn, Mainau





presents a magnificent view of an ever-changing sea of flowers. We then continue to the Hofgut Sternen hotel in the Black Forrest. In the Evening we enjoy a Black Forrest buffet with folk dancing. **B/D**

Wednesday, July 21, 2021 • Rüdesheim

Today our first stop is an open-air living museum at Gutach in the Black Forest. Go back in time to the 16th Century and discover the world of the Black Forest farmers. We see the way they lived and worked as we explore their farmhouses and mills. After the tour we continue to Rudesheim, the most picturesque of the Rhineland wine villages. **B/D**

Thursday, July 22, 2021 • Rüdesheim

We spend the morning with "Vater Rheine" the granddaddy of the German waterways. A cruise on the most scenic segment of the river takes us past majestic medieval castles and fortifications perched high on the banks overlooking the river. You encounter picturesque villages with pointed church spires and countless immaculately kept vineyards. We get off the ship at St. Goarshausen, continuing in our coach to Braubach, where we have a tour of Germany's best-preserved medieval castle, the Marksburg! Later, we are back in Rudesheim for time on your own to do some last-minute shopping, pack for your trip home, or just to wander around the city. This evening we kick back and enjoy the world famous "Drosselgasse" with its many wine bars that offer live music and dancing. This city is the perfect place for us to end our tour of the Alpine countries. **B/D**

Friday, July 23, 2021 • Frankfurt/USA

Sadly, it is time for us to return to the USA. Our tour has been relaxing and filled with many wonderful memories. We have enjoyed the Gemutlichkeit of Bavaria, the beautiful Rhein river, the castle of a king, the spectacular Alps, and of course the music of Austria. We take with us friendship and memories that last a lifetime. **B/F**

Currency:

Currency exchange rates fluctuate constantly. In the event of a significant drop in the value of the dollar, we reserve the right to add a currency surcharge to the price of the tour.

Refund/Cancellation Policy:

All cancellations must be in writing. The date of postmark will determine the amount of refund due. Refunds are based on the number of days prior to departure date. From the time of deposit to March 13, 2021 a \$100 administrative fee plus any airfare penalties will be assessed. From March 14 - June 28, 2021, a \$300 cancellation penalty plus lost airfare deposits and any unrecoverable deposits to ground suppliers will be assessed. Airline tickets once purchased are nonrefundable. Anyone canceling June 27, 2021 or after will receive no refund.

Purchase of health, baggage, and trip cancellation/interruption insurance is strongly recommended.
