We'll visit the Rijkmuseum, which features eight hundred years of national history, see paintings by Dutch Masters, and learn about folk art at the Museum Hindeloopen. We'll also have time for additional adventures and independent exploration.

Day 1: Friday, September 19, 2025 • Departure

Our journey begins as we board our international flight bound from Chicago O'Hare to Amsterdam, Netherlands. **Inflight meals**





Day 2: Saturday, September 20, 2025 • Amsterdam

Upon arrival at Schiphol Airport, we take a short walking tour of Amsterdam, including a scenic canal boat tour that provides a beautiful overview of the city's iconic canals, historic bridges, and charming neighborhoods. We transfer to our hotel for checkin. This evening, we enjoy a special welcome dinner along the canals, setting a perfect tone for our time in Amsterdam. **D**

Day 3: Sunday, September 21, 2025 • Amsterdam

This morning, we dive into Dutch culture with a visit to the renowned **Rijksmuseum**, where we explore a rich collection of Dutch art and artifacts, including masterpieces by Rembrandt, Vermeer, and Van Gogh. The rest of the day and evening are free to explore Amsterdam at our leisure. **B**

Day 4: Monday, September 22, 2025 • Amsterdam

Today, we board a coach and head north to Enkhuizen to visit the Enkhuizen Open Air Museum, a captivating showcase of the unique history and culture of the Zuiderzee region before the creation of the IJsselmeer. After lunch on our own in this charming town, we head to the Museum Hindeloopen, where we discover the rich traditions of folk art and maritime heritage, including the colorful and distinctive Hindeloopen paintings. We return to Amsterdam in the evening and dine as a group. B, D

Day 5: Tuesday, September 23, 2025 • Amsterdam

We enjoy a free day to explore Amsterdam's many highlights at your leisure. Make sure to reserve tickets in advance for the Anne Frank House or consider other cultural stops like the Van Gogh Museum, Stedelijk Museum, or the Resistance Museum. Wander through the neighborhoods, shops, or relax by the canals for a memorable day in the city. **B**





Day 6: Wednesday, September 24, 2025 • Amsterdam
This morning, we drive to Arnhem to visit the Dutch Open-Air
Museum, where we experience Dutch culture with its historic
windmills, farmhouses, and traditional crafts. Next, we explore
the Kröller Müller Museum in Hoge Veluwe National Park,
home to the second largest Van Gogh collection in the world.
We return to Amsterdam for a relaxing evening, with dinner at
our hotel. B, D

Day 7: Thursday, September 25, 2025 • Bruges

After checking out of our hotel, we drive to Antwerp to visit the **Red Star Line Museum**, which tells the stories of migrants who journeyed to America on this historic shipping line. We continue to Bruges, where we take a canal or walking tour to explore the city's medieval streets, canals, and landmarks like the Belfry. After checking into our hotel, we have dinner this evening. **B**, **D**

Day 8: Friday, September 26, 2025 • Bruges

We visit the Kantcentrum Lace Museum, located in the former School of the Apostoline Sisters, where Seraphine would have trained as a lacemaker. We learn about Bruges' rich lace-making heritage. The afternoon we explore the Gruuthuse Museum and Historium Brugge. We have time for a bit of shopping for lace souvenirs. Tonight, we savor Flemish specialties like moulesfrites or waterzooi during dinner at a scenic canal side restaurant. B, D

Day 9: Saturday, September 27, 2025 • Bruges

Our day begins at the bustling market at 't Zand Square, browsing stalls of fresh produce, artisanal foods, and local wares. Later, we venture to Ghent for a walking tour and a visit to **St. Bavo's Cathedral** to view the **Ghent Altarpiece**. We return to Bruges this evening for dinner on our own. **B**

Day 10: Sunday, September 28, 2025 • Brussels

Today we drive to Brussels where a local guide joins us for a city tour combining some driving and walking. Our sightseeing includes the breathtaking Grand-Place, one of the most beautiful squares in the world, it's 15th century Town Hall and its richly decorated late 17th century Guild Houses, the Royal Palace, the smallest and most famous irreverent inhabitant, Manneken-Pis. We also see Notre Dame du Sablon, Park-du-Cinquantenaire, Atomium and St. Michael Cathedral. Tonight, we enjoy a farewell dinner together. **B, D**

Day 11: Monday, September 29, 2025 • Return

We transfer to the airport for our return flights, bringing home memories of our extraordinary journey. **B**

Payment Schedule:

A deposit of \$750 per person is due with reservation. A 2nd deposit of \$1,000 is due March 26, 2025.

Final payment is due 90 days prior to departure date (June 21, 2025). Invoice will be sent out prior to final payment. Passengers may add after this date subject to air and land availability. Generally airlines do not increase the price of a ticket after it has been contracted. However, prior to the issuance of a ticket, airlines may (and regularly do) impose fuel, tax, or security surcharges. In the event a surcharge is imposed after Ed-Ventures has received a final payment, Ed-Ventures will send an additional invoice for the surcharge amount. Early registration is encouraged.

Currency:

Currency exchange rates fluctuate constantly. In the event of a significant drop in the value of the dollar, we reserve the right to add a currency surcharge to the price of the tour.

Refund/Cancellation Policy:

All cancellations must be in writing. The date of postmark will determine the amount of refund due. Refunds are based on the number of days prior to departure date. From the time of deposit to 120 days before departure a \$100/person administrative fee plus any airfare & land penalties will be assessed. From 119-46 days, a \$300/person cancellation penalty plus lost airfare deposits and any unrecoverable deposits to ground suppliers will be assessed. Airline tickets once purchased are non-refundable. Anyone canceling 45 days or less prior to departure will receive no refund.

Purchase of health, baggage, and trip cancellation/interruption insurance is strongly recommended.

Terms and Conditions

In the event of cancellation of the trip in its entirety, a full refund of all deposits will be made to passengers enrolled at the time of cancellation.
