Day 1: Monday, December 1, 2025 • Departure
Our journey begins as we board our transatlantic flight to Rome, Italy.

Day 2: Tuesday, December 2, 2025 • Rome
Upon arrival at Rome’s International Airport, we meet our local guide and drive to the **Church of Santa Prisca** located in the area of **Circus Maximus** in the valley between the Aventine and Palatine hills. It was here chariot races were held in ancient times. The racetrack was traditionally the property of the Priscii family. At the church, we are introduced to the patron saint and the potential roles she played in the early Christian Church and as a contemporary of Peter and Paul. We also visit the **Church of St Aquila and Priscilla**, two Jewish-Christians who were very dear to the Apostle Paul for their passionate collaboration in spreading the word of Jesus in Corinth and Ephesus. We end our day with Mass and then transfer to our hotel for a welcome dinner tonight. **D**

Day 3: Wednesday, December 3, 2025 • Rome
After breakfast we depart for the **Vatican** and a **Papal Audience** with the Holy Father. Following our audience with the Pope, our sightseeing begins with a tour of the **Vatican Museum** with its magnificent art collection and the **Sistine Chapel** with Michelangelo’s masterpiece and deeply moving interpretation of Christianity. We see Pieta, the Tapestries Gallery and the Belvedere with its marvelous statues. We also tour **St. Peter’s Basilica**, the largest Christian church in the world, and the Scavi excavations beneath the crypt of St Peter. **B/D**

Please be aware that Scavi tours are offered on a limited basis each

day and that the itinerary for December 2025 is subject to change in order to accommodate the Scavi Tours and Vatican bookings. All items included in the itinerary will be included albeit the order may change.

Day 4: Thursday, December 4, 2025 • Rome
Today we visit the convent of the Benedictine Sisters of Priscilla where we enter Rome’s oldest catacombs. The **Catacombs of Saint Priscilla** with the earliest painting of Mary and the baby Jesus, and its two chapels emphasizing frescoes of women, the Capella Greca with its triclinium and the Velation, causes us to ponder what motivated this focus on women. We also see the ancient tombs of Christian martyrs, other thousand-year-old frescoes and awe at the silent beauty of this unique place. Our afternoon begins at the **Colosseum** and includes a walking tour of ancient Rome. We stroll through the **Roman Forum** and the ruins of 2000 years ago imagining what it must have been like as we see the tracks the chariot wheels left behind. We see the Arch of Titus, Constantine’s Arch, San Pietro in Vincoli Church with Michelangelo’s Moses, and Mamertine Prison where we reflect on Paul’s time spent in Rome. **B/D**

Day 5: Friday, December 5, 2025 • Rome
This morning, we visit the **Churches of St. Praxedis and St. Prueniana** and hear the story of the daughters of St. Pudens who were murdered for providing Christian burial for early martyrs in defiance of Roman law. St. Pudens is traditionally identified as St. Peter’s first Christian convert in Rome. We enjoy pranzo (lunch) together. Next, we see the **Milivan Bridge** where the battle Constantine I and Maxentius took place and learn about the

beginning of Constantine's conversion to Christianity. We visit the **Ara Pacis Museum**. On display are more than 240 artworks which tell the history from the Roman era of theatrical performance and gives a cultural insight into the production process and the lives of those who passed on the stories of the times. We have the remainder of the day free to explore the piazzas, gelato stands and other sites on our own. **B/L**

Day 6: Saturday, December 6, 2025 • Rome

On our agenda today is a visit to **St. John Lateran**, the Pope's cathedral church where relics of both Peter and Paul remain under the main altar. We see the Scala Sancta and the Shrine of Pope John. We have an opportunity to walk across the **Holy Door** only open in a Jubilee year and symbolizes the passage from sin to grace. We also visit the **Crypts of San Clemente**, one of the world's great treasures and loved by pilgrims, art students and many other visitors from around the world. Later, we follow the ancient **Appian Way**, the traditional pilgrims' route followed by Peter and Paul. We have the remainder of the afternoon free until dinner together. **B/D**

Day 7: Sunday, December 7, 2025 • Rome

After breakfast, we drive to **Ostia Antica** the former port of Rome that was abandoned around 400 A.D. due to disease and silt. Excavations began in 1909 and the ruins now give a fascinating glimpse into everyday life in ancient Rome. We learn how the grain ships came in from Egypt and were off-loaded into silos, or barges to Rome to fulfill the Roman populace every fall. We hear the stories of two of the most famous passengers through this port, Saint Augustine and his mother Saint Monnica. We see her tomb inscription in the church of Saint Aurea and visit, inside the excavation, the city church which Monnica and Augustine probably attended. We see the sculptured sarcophagus of a woman Bible teacher. Tonight we have a farewell dinner and time of reflection together. **B/D**

Day 8: Monday, December 8, 2025 • Return

This morning, we transfer to the airport for our flight home. **B**

All cancellations must be in writing. The date of postmark will determine the amount of refund due. Refunds are based on the number of days prior to departure date. From the time of deposit to 120 days before departure a \$100 administrative fee plus any airfare penalties will be assessed. From 119-31 days, a \$300 cancellation penalty plus lost airfare deposits and any unrecoverable deposits to ground suppliers will be assessed. Airline tickets once purchased are nonrefundable. Anyone canceling 30 days or less prior to departure will receive **no refund**.

Purchase of health, baggage, and trip cancellation/interruption insurance is strongly recommended.
